## **Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 27 June 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

### **Your Request**

As of the 21st of June 2023, who were the listed partners for the GP practice in Felton, and/or the GP Partners in Northumberland Health? If the GP's who are Partners has changed, when did the ICB become aware of this change?

### **Our Response**

The listed partners of Northumberland Health are Dr Yvonne Lees and Dr Chris Waite.

Both GPs are listed partners of the Northumberland Health contract as of 21 June 2023. Felton surgery is a branch site of Northumberland Health; Widdrington Surgery is the main site.
