Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 18 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Would you please supply me copies or direct me to where I can view on your website the applications made over the last 24 months, from those applying to open a new pharmacy in the locality of Chillingham Road, Heaton, Newcastle upon Tyne, NE6 or surrounding area within a half mile radius of Chillingham Road.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

The following data relates only to new pharmacy applications (excludes Consolidations/changes of ownership and relocations). In the last two years, there have been 8 applications to open a new pharmacy in the Chillingham Road Area – these are listed below, and the documents circulated during the notification stage are attached.
