<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board (ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 14 October 2022 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Details of Request

I am writing to you under the Freedom of Information Act 2000 on behalf of Crohn's & Colitis UK to request the following information:

Do you have a clear pathway in primary care for the investigation of non-cancer related lower gastrointestinal symptoms that include the use of faecal calprotectin tests?

If so, I would appreciate if you are able to share any details you may have.

Response

North Cumbria Locality

North Cumbria have a number of pathways that utilise faecal calprotectin in Primary Care. These are housed on our Community Health Pathways site.

The pathways which include the use of faecal calprotectin are:

Colorectal symptoms

Acute abdominal pain in adults Inflammatory bowel disease Irritable bowel disease.

These pathways are widely available for use for all Primary Care staff and for hospital and community staff as well via the Health Pathways site.

Tees Valley Locality

Please refer to attached, the pathway was first developed in 2018 and is in line with NICE Guidance DG11 (faecal calprotectin diagnostic tests for inflammatory diseases of the bowel) and the NICE guideline on suspected cancer.
