<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 8 November 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Request

I emailed you 3 weeks ago to ask what Northumbria's policy on gf prescriptions is, so I can take the information to my doctor. I have had no reply.

I have been informed that some people are able to get gf prescriptions in Northumberland, and yet my GP stopped these several years ago

Response

Whilst we are unable to comment on particular clinical cases I can confirm that the Northumberland ICB encourages practices to prescribe gluten free products in line with our area prescribing committee guidance which is publicly available at Gluten-free-guidelines-March-2022.pdf (northoftyneapc.nhs.uk)
