Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 15 February 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

For each of the following years, could you please send me the statistics on women/people assigned female at birth who have a confirmed or suspected gynaecological condition (endometriosis, PCOS etc) and have been prescribed a long-term reversible contraceptive such as an implant or coil instead of having a more thorough investigation (laparoscopy etc) into their symptoms.

I require the above information for the years 2019, 2020, 2021, and 2022.
