## **Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 21 September 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

### **Details of Request**

Under the FOI Act, please could you provide the following information.

For each of the past financial years, starting from 2019/20 and including 2023/24 to date (21 September):

How many of the following have been declared by your organisation

- Business continuity incident
- Critical incident
- Major incident

These are incidents defined by the NHS England Emergency Preparedness, Resilience and Response Framework.

For each incident, please detail the type of incident declared, the reasons why they were declared, and how long the incidents were in place for.

Please split this data by financial year.

ICBs were legally established on 1 July 2022 so the information only covers the period July 22 to September 23.
