Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 8 November 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Request

I am writing to make a Freedom of Information request regarding the availability or restrictions on liquid formulation antidepressants within your ICS. We have reviewed the available information on the South Tyneside and Sunderland formulary website and there does not seem to be much information about restrictions on the use of liquid formulations.

Please could you let me know the following with reference to the primary care prescribing of antidepressants for depression and/or anxiety:

- 1. Are there any internal documents or guidelines that restrict the prescribing of liquid antidepressants?
- 2. Do you have any guidance for prescribers regarding tapering of antidepressants? If so, could you provide a copy of the relevant documents.
- 3. Do you use any prescribing decision support software, or other tools such as PMR system searches, which identify prescribing of liquid antidepressants and recommend a switch to other formulations?
- 4. Do you engage in any proactive correspondence with practices to encourage other formulations over liquid formulations? Please do not hesitate to contact me via this email address should anything require clarification.

Newcastle Gateshead

- 1 No, but we would expect prescribing to be in line with the formulary: http://northoftyneandgatesheadformulary.nhs.uk/default.asp
- 2 We have a guide to support prescribers in deprescribing dosulpein in line with NHSE guidance. However, it is expired and requires review. Out of date document attached "Position statement dosulepin in primary care v1.0".
- 3 Yes, Optimiserx. We have messages switched on to advise switching away from a liquid preparation.

North Cumbria

- 1. No. We recommend prescribers to follow North of Tyne formulary http://northoftyneandgatesheadformulary.nhs.uk/ We have guidance on use of licensed/unlicensed medicines https://medicines.necsu.nhs.uk/download/special-order-pharmaceuticals-prescriber-guide/?tmstv=1668174278 Our internal documents do not explore prescribing and signpost to specialists and NICE guidance see attachment "Depression in Children and Adolescents Community HealthPathways North Cumbria".
- 2. No. We signpost to NICE guidance as per Q1.
- 3. We use Optimise Rx.

Amitriptyline

Oral solution/suspension 10mg in 5ml (unlicensed) to oral solution sugar free 10mg/5ml (licensed), 1 entry.

Dosulepin

Oral suspension (unlicensed) to oral solution (unlicensed), 1 entry As above to tablets (licensed), 1 entry.

Fluoxetine

Fluoxetine oral solution 20mg in 5ml to capsules, 1 entry.

Fluoxetine oral solution sugar free 20mg in 5ml to fluoxetine 20mg dispersible tablets, 1 entry.

Fluoxetine oral liquids to fluoxetine 20mg dispersible tablets, 1 entry.

<u>Paroxetine</u>

Paroxetine 10mg/5ml sugar free oral suspension – product discontinuation notice, 1 entry.

Trazodone

Trazodone oral solution sugar free to solid-dose formulations, 1 entry.

<u>Venlafaxine</u>

Venlafaxine oral solutions (unlicensed) to venlafaxine tablets (licensed) – off label use, 2 entries.

Venlafaxine oral solutions (unlicensed) to venlafaxine oral solution sugar free (licensed), 2 entries.

North Tyneside and Northumberland

- 1. The North of Tyne, Gateshead and North Cumbria APC formulary details antidepressant choice, the APC has also endorsed a Swallowing Difficulties guideline. Beyond these guidelines there are no further documents regarding liquid antidepressants.
- 2. No.
- 3. Both Sub ICB Locations use Optimise RX

There are several messages active in Northumberland and North Tyneside that would advise a switch away from a liquid preparation, either from a cost or licensing perspective, depending on clinical circumstances and the ability of a patient to swallow. These messages are all for consideration, rather than direction. E.g.

- > Fluoxetine oral liquids (brands, generics): consider swapping to fluoxetine 20mg dispersible tablets
- 4. Other than advice in APC formulary which says fluoxetine dispersible in preference to liquid there's no other advice to clinicians.

South Tyneside

- 1. There are documents restricting the use of liquid antidepressants
- 2. There is a guideline for deprescribing of anti-depressants see link below
- Antidepressant Deprescribing Guidance (195 downloads)
- 3. OptimiseRx decision support systemin place. Switches to other formulations are not currently recommended
