Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 23 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

1. Please could you also share all NHS providers of mental health services and for each NHS provider, which services they are commissioned to provide by the ICB.
2. Please could you also state independent sector providers of mental health services and for each NHS provider, which services they are commissioned to provide by the ICB.
3. Please could you provide service specifications where they exist.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

The attached spreadsheet "NENC ICB mental health contracts – master" indicates the contracts/services in place and answers all 3 points to the best of NENC ICB ability.

Column H in the spreadsheet is the key to find the service specification in the zipped file "service specs". In addition, grants do not have service specifications and are highlighted in yellow on the spreadsheet.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log.
