Freedom of Information Act 2000 - Request for Information - NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your Freedom of Information (FOI) request received by the North East and the North Cumbria Integrated Care Board (NENC ICB) on 14/02/2024.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland, and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

I am requesting the following information under the Freedom of Information Act regarding the community health services for speech and language.

Please can you provide the following in the format of an Excel spreadsheet:

- 1. The total number of patients currently on the waiting list to receive speech and language therapy services.
- 2. A breakdown of the waiting list by age groups (0-5 years, 6-10 years, 11-15 years, 16-18 years, 18+ years) for the latest calendar year 2023.
- 3. A breakdown of the number of patients by age group waiting from referral to first appointment:
 - a. 0-1 weeks (0-7 days)
 - b. 1-2 weeks (8-14 days)









- c. 2-4 weeks (15-28 days)
- d. 4-12 weeks (29-84 days)
- e. 12-18 weeks (85-126 days)
- f. 18-52 weeks (127-364 days)
- g. Over 52 weeks (over 365days)
- 4. Historical data on the waiting list the total number of patients waiting for speech and language services, a breakdown by age group and weeks waiting for 2019, 2020 and 2021 or the latest year for when records began.
