Thank you for your request received by North of England Commissioning Support (NECS) on 18 August 2022 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please could you tell me whether you implement a 'same-sex' personal care policy for your social care service users? Or if you have moved to a 'gender based' policy?

Does this policy apply to social care users who receive CHC funding provided by you, as well as those who receive council funded social care?

Please provide proof of your policy.

Do you instruct all care agencies in the area to comply with your policy or are each able to implement their own policy?
