# <u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 15<sup>th</sup> August 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Whilst there has not been a formal reduction in these actual rates – these figures do not represent or reflect the number of individuals that have been discharged in this time in relation to new admissions or those individuals that have had a diagnosis whilst in hospital of Autism or Learning Disabilities. I also want to note that the FOI talks about 'beds' – the numbers I have provided are for the number of individuals who are in hospital at that time.

EPPIC (Early Potential Patient Indication Concern) Is also a template that we request is completed prior to a community CTR taking place to ensure that the individual is receiving the right support at that time in relation to whether an enhanced MDT (EPPIC+) is required or a C(E)TR.

- 2. Appointed Learning Disability & Mental Health Coordinator 2020 to support community and inpatient services with complex cases who are at risk of placement breakdown and hospital admission.

Development of the Dynamic Support Register across Children and Adults, working closely with local authority commissioning to develop services and link with specialist providers to address current gaps in service provision.

CETR's running more seamlessly and closer links with the trusts to look at delayed transfers of care and inappropriate admissions.

Attendance to CPA/MDT's looking at preventative strategies rather than reacting to crisis, adopting a more needs led service to ensure the right wrap around support with the appropriate skill level is supporting the individual.

- Commissioned an enhanced community model from CNTW working with individuals at risk of admission (identified via DSR) and also current inpatients to reduce LOS/facilitate discharge.

  - Training in learning disabilities and/or autism for the local crisis house to be considered as an alternative to hospital admission.

2. South Tyneside Learning Disabilities Alliance has oversight of all key deliverables within our delivery plan.

South Tyneside has employed two discharge co-ordinators whose role is to support with a clear discharge plan for adults with a Learning Disability and / or Autism in an inpatient setting.

In addition, the revised Care (Education) Treatment Review (C(E)TR) process has been signed off with a process that highlights a clear pathway for when a C(E)TR should be actively considered as well as providing robust quality assurance. Quality assurance meetings provide a continued cycle for improvement. Employment of experts by experience support the 6-8 quality assurance visits and ensuring the voice of the patient is heard.

- Sunderland's enhanced community care model which is closely monitored and led by the Senior Commissioning Manager to ensure our local ways of working are fully utilised to prevent deterioration in the community and inappropriate admissions to hospital has proved to be effective alongside our local CTR / MDT Plus processes;
- Health and social care working together via their local transforming care meetings looking at patients who are due to be discharged and planning appropriately for those discharges;
- Commissioning bespoke packages of care in the community which was further supported by some capital bids funding which were successful due to detailed transition plans from hospital back into the community for individuals who had spent significant time in hospital.
