Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 5 September 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows;

Request

I am writing to you under the Freedom of Information Act 2000 to request the following information. We are conducting a study of the typical capital cost of setting up a Community Diagnostic Centre, I had originally submitted a request to the South Tees Hospitals NHS Foundation Trust, who informed to contact you instead.

Please could you provide me with a copy of the business case for the Trust's Community Diagnostic Centre project, including the capital budget for the entire project.

Response

The development of the business case is ongoing, therefore the ICB is unable to provide this information as it is not yet held. The scheme is being developed in collaboration between North Tees and South Tees Trusts.

Capital funding/budget is attached to the proposed scheme once the business case is approved and until we conclude the development stages, we will not know the expected cost to deliver the desired CDC for Tees Valley.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
