<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board (ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 September 2022 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria Integrated Care Board (ICB).

Details of Request

Under the Freedom of information act I am requesting all correspondence regarding the building of the new surgery in Felton, Northumberland between Northumberland CCG, the builders and Drs Lees and Waite.

I would particularly wish to see information regarding any reasons for the delays between 2016 to 2022 and why other building companies dropped their bids to build the new surgery.

I also request any communication regarding the current lease at 51 Main Street between the CCG and Drs Lees /Waite between 2019 and 2021.

Response

On 14th October 2022 you kindly clarified you wish to receive all information held.

NHS North East and North Cumbria ICB do hold the requested information; however, your request is exempt under section 12 of the Freedom of Information Act 2000 as it exceeds the appropriate limit.

The scope of the request is such that the time and cost required would exceed the appropriate limit, which is currently set at £450 for the ICB, which equates to 18 hours or

more of an officer's time. This is due to the breadth and depth of searches that would be necessary, and the considerable length of the time period that they cover. The ICB to conduct a manual exercise to retrieve this information, searching not only formal correspondence but extensive searches of current and historic email records for a number of key individuals using particularly broad and generic search terms (e.g., 'Felton', '51 Main Street', 'new surgery' etc.).

The ICB's calculations is that it would take a total of 30 hours, at a minimum. This would provide an estimated cost of 30 hours x £25 per hour = £750 and is therefore outside the data collection limits.

In addition, under Section 16 FOI Act 2000, the ICB have a duty to provide advice and assistance. The ICB may be able to comply with a refined request. For example, narrowing down the time period for which information is being requested or being more specific in terms of the nature of the correspondence being requested. Please note that these are only suggestions of what the ICB would be able to provide and not categorically what they can provide within the prescribed cost limit.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log.
