**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 8 October 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Please can you provide the following information, under the Freedom of Information Act 2000, linked to all CHC funded packages for your ICB, for both children and adults.

1. What is your monthly, quarterly, and annual CHC spend for adults?
2. What is your monthly, quarterly, and annual CHC spend for CYP?
3. What levels/volumes of referrals in total package hours that you put out to market each week/month/quarter/year, based on the last 12 months activity, for both children and adults?
4. What are the numbers of package types referred by your ICB CHC team monthly, quarterly, annually, based on the last 12 months, covering the following conditions:
  - a. Spinal injury,
  - b. ABI,
  - c. Tracheostomy and ventilation,
  - d. Long term complex conditions.

## Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

### Questions 1 and 2

NENC ICB has responded to questions 1 and 2 on behalf of the whole ICB, except South Tyneside place.

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information in respect of South Tyneside. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by South Tyneside Council.

#### **Q1: Spend for Adult CHC:**

### Questions 3 and 4

NENC ICB has responded to questions 1 and 2 on behalf of the whole ICB, except South Tyneside place. To confirm, the information is not held for South Tyneside.

#### *County Durham, Sunderland and Tees Valley places*

**Q3:** Packages of care are purchased based on need and are not via a market.

**Q4:** The CHC system does not record referrals according to the diagnosis.

#### *Newcastle Gateshead, North Cumbria, North Tyneside and Northumberland places*

**Q3:** Levels/volumes of referrals in total package hours are not recorded in these ICB places.

**Q4:** Numbers of packaged types of these conditions is not recorded in these ICB places.
