For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB).

- How many VR machines do you have and what are the age of these machines?
- How many YAG lasers linked PCO (Posterior capsule Opacification) after cataracts have you undertaken between: 2019-2020 2021-2022 Calendar Year
- Do you have any subcontracting arrangements for Cataract Surgery with the independent sector within this financial year, if so please provide details including volumes?
- Who is the procurement lead or lead Trust for Ophthalmology on behalf of your ICS, and what plans do you have for Ophthalmology?
