Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 22 November 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am requesting under the Freedom of Information Act a list of all the community diagnostic centres and their addresses in your area (both operational and any being developed), as well as the number of MRI machines at each diagnostic centre, and the age/date installed, make, manufacturer and specification of the MRI machines (e.g. installed in Dec 2022, GE Signa Architect, 3.0T) and if any AI software is installed and in use on them.

Our Response

Details of Community Diagnostic Centre (CDC) sites, and those that have MRI machines that are owned by the NHS is below.

Bishop Auckland CDC (County Durham and Darlington) – 1 x MRI NHS
Blaydon CDC (Gateshead Health) – 1 x MRI (IS Mobile) – Interim CDC
Metrocentre CDC (Gateshead Health) – not yet operational
Penrith CDC (North Cumbria) – 1 x MRI (IS Mobile) – Interim CDC
Workington CDC (North Cumbria) – not yet operational
Tees Valley Friarage CDC (South Tees Hospitals) – 1 x MRI NHS
Tees Valley Redcar CDC (South Tees Hospitals) – 1 x MRI NHS, not yet operational
Tees Valley CDC Hub (North Tees and Hartlepool) – not yet operational

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold all the information which you have sought. However, we have determined the records are held by Acute Hospital NHS Foundation Trusts within the North East and North Cumbria region.
