Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board

Thank you for your request received by North of England Commissioning Support (NECS) for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

This response to this request has been provided for the North Cumbria locality only, following your clarification provided on 15 December 2022.

Please be advised that this response includes information held by the ICB and also, nationally available data.

Original Request and ICB Response:

1. About Your Region:

- a. How many people is your ICS (Integrated Care System) responsible for providing healthcare to?**

North Cumbria Practice Population on 30th November is 331,662.

- b. How many GP Practices operate in your region?**

There are 35 practices in the North Cumbria locality.

c. How many Primary Care Networks operate in your area?

There are 8 PCN's within the North Cumbria locality.

d. How many GP Practices participate in Primary Care Networks?

All 35 practices are part of one of the 8 PCN's in North Cumbria.

2. About The Learning Disability Register in Your Region:

a. How many GP practices in your region report that they maintain and establish a learning disability register?

All 35 practices in North Cumbria have a QOF LD Register.

b. How many people with a learning disability are on a learning disability register across your ICS region?

1907 patients are on the LD register across North Cumbria practices, as of 11th November 2022.

c. How many of the people on a learning disability register across your ICS region are aged 14 and over?

1788 patients on the LD Register across north Cumbria practices are aged 14 and over on 30th November 2022.

d. How many of the people on the learning disability register across your ICS region are from a Black, Asian or minority ethnic background? (Backgrounds other than White British)

1,164 patients received an annual health check in 2021/2022.

c. How many people on the learning disability register received an annual health check AND a health action plan in 2021/22 in your ICS region?

1070 patients received a health check and action plan in 2021/2022.

4. About Quality Improvement:

How many practices in a) your ICS region, and b) each PCN respectively, completed the learning disability quality improvement modules from the 2021/22 QOF. These are:

- **QILD007 - The contractor can demonstrate continuous quality improvement activity focused upon learning disabilities as specified in the QOF guidance.**
- **QILD008 - The contractor has participated in network activity to regularly share and discuss learning from quality improvement activity focused on the care of patients with a learning disability as specified in the QOF guidance. This would usually include participating in a minimum of two network peer review meetings.**
